OVERVIEW AND FUNDING HISTORY




FIG. 1 GCTF APPROPRIATIONS FROM THE GUAM LEGISLATURE, FY2011-FY2022

The Guam Cancer Trust Fund (GCTF) is a special fund created by Public Law 30-80 in 2010 and provides financial assistance to organizations that provide patient-directed services for the prevention of cancers, its treatment, diagnosis, and other services that may be required to access treatment, including, but not limited to, off-island transportation and temporary housing. Additionally, up to 10% of available funds are used for cancer education and outreach programs (P.L. 32-216). According to the founding legislation, (P.L. 30-80), 15% of taxes collected from tobacco taxes and placed into the Healthy Futures Fund is supposed to go towards funding the GCTF; and the University of Guam was given the responsibility to administer and manage the GCTF. Since its inception in 2010, the GCTF has received a total of \$16,379,659. See Table 1 and Figure 1.

LEGISLATIVE APPROPRIATIONS TO GCTF (\$ MILLION)

Financial assistance from the Guam Cancer Trust Fund is not directly provided to cancer patients. Rather, financial assistance is provided to non-profit and charitable organizations that provide cancer screenings, treatment and support services, cancer education and outreach programs. These organizations must apply for this funding. Since 2011, the Guam Cancer Trust fund has provided funding to several organizations who provided "direct services" to cancer patients (Table 2) and "education & outreach services" for cancer prevention and education (Table 3).

AWARDEES FOR FY2021

• Edward M. Calvo Cancer Foundation (Awarded: \$660,000)

The Foundation offers its patient services program for the primary purpose of improving the quality of life for local cancer patients in Guam by providing financial assistance for costs directly associated with cancer treatment. While the Foundation is unable to provide for the cost of full-time care and medical treatment, the patient services program provides grants that patients may use to cover certain expenses that are not normally covered by medical insurance, such as nutritional supplements, airfare, ground transportation, medical equipment such as wheelchairs, lodging and rehabilitation items such as wigs and prostheses.

• Catholic Social Services (Awarded: \$313,409)

The Enkatgao Project is one of our newly funded grant programs for the unpaid caregivers of individuals undergoing cancer treatment or who are terminally ill. Enkatgao will assist up to forty unpaid family caregivers by providing limited in-home respite services for the patient, selfcare help, stress relief activities, and monthly training sessions for the caregiver. "Enkatgao" is the Chamorro word for caretaker or custodian. Caregiving is stressful and emotional, especially for family members caring for individuals with chronic or terminal illness. The stress for caregivers can be devastating and lead to fatigue and risk physical abuse or neglect of the ill family member. It may result in the caregiver neglecting their own health as they focus on care of their family member.

American Cancer Society (Awarded: \$127,890)

ACS is the nationwide, community-based, voluntary health organization dedicated to eliminating cancer as a major health problem by preventing cancer, saving lives, and diminishing suffering from cancer, through research, education, advocacy, and service. ACS has become a world leader in transforming cancer from deadly to treatable, and from treatable to preventable. We save lives and diminish suffering through a comprehensive set of programs that reduce the risk of cancer, promote early detection, ensure proper treatment, and empower people facing cancer to cope with the disease and maintain the highest quality of life possible. ACS advocates on behalf of patients' issues and fights for every life threatened by every cancer in every community. Our regional and local offices are organized to engage communities in the cancer fight, while delivering lifesaving programs and services to cancer patients and their families.

Santa Teresita Catholic Church (Awarded: \$27,734)

Santa Teresita Catholic Church mission is "Empowered by the spirit of Santa Teresita, our parish exists to serve, strengthen, and nourish the physical, spiritual, and emotional needs of the Church community of God. In doing so, it carries the light of Christ and light of love in this ever-changing world."

AWARDEES CARRIED OVER FROM FY2020

Some FY2020 Awardees were carried over into FY2021 because they were not able to fully execute their programs and subsequent spending in FY2020 due to COVID-related challenges. Therefore, with permission from the GCTF Council, they were permitted to carryover their programs and expenditures into FY2021.

• Guam Cancer Care (Awarded: \$823,550 for direct services and \$81,567 for education and outreach services)

Guam Cancer Care's mission is to provide cancer care assistance to all individuals afflicted by cancer. Through navigation and advocacy, we strive to provide enhanced assistance throughout the screening and treatment process. Additionally, by minimizing barriers to financial assistance, cancer education, and other support services, we ensure patient satisfaction throughout the continuum of cancer care.

Ayuda Foundation (Awarded: \$671,480.00)

The Guam Cancer Assistance Program helps cancer patients and their escorts with the cost of air travel to and from their place of treatment. This program is made possible by a grant from the Guam Cancer Trust Fund. The program is administered by Ayuda Foundation's Wings for Life, an initiative dedicated to alleviating the financial burden of medical travel for Guam patients. Ayuda Foundation can process coverage for your airfare once your travel itinerary is confirmed. Coverage is available for the patient and one escort.





TYPES OF AID GIVEN TO CANCER PATIENTS

1. American Cancer Society- Direct Services

- a. Reimburse patients for travel expenses including airfare and lodging to cancer treatment in Hawaii, the Philippines, and the mainland.
- b. Offer educational materials such as informative guidebooks to cancer patients and their caregivers to help navigate the cancer treatment process.
- c. Provide cancer patients with gas cards to cover travel to on-island cancer treatment facilities.
- d. Equip cancer patients with supplies and personal accessories that contribute to their health and wellness such as head coverings, mastectomy bras, comfort pillows and more.

2. Ayuda Foundation - Direct Services

a. Airfare purchases for patients and escorts.

3. Edward M. Calvo Cancer Foundation-Direct Services

- a. Patient Services /Financial Grants
 - Doctors' appointments, cancer treatment, medication, travel and transportation, support services/counseling, at home care, short term housing during treatment, cosmetic items to address side effects, equipment, and other.

4. Guam Cancer Care-Direct Services

- a. Patient Navigation and Advocacy
- b. Financial Assistance Program (FAP)
- c. Transportation Assistance Program
- d. Patient Support Services Program
- e. Cancer Screening and Early Detection Program


