#### III. REPORT FROM THE CHAIR

#### Financial Report as of 5/31/2021 - Dr. Rachael Leon Guerrero

- i. Total cash in account \$2,479,415.00
  - Allocated \$2,348,948.00- allocated towards the different projects
  - Unallocated \$130,466.00 -amount will be carried over to FY 2022
- For FY2022, we anticipate receiving applications from 7 non-profit organizations; and if they request funding like their previous funding requests, then the total ask would be approximately \$2.4million.

#### V. OLD BUSINESS

- a. Request members of 36<sup>th</sup> Guam Legislature Committee on Health, Land, Justice and Culture to consider increased funding for FY2022
  - i. Drafted a letter to request for additional funding (*R. Leon Guerrero*)
  - ii. Drafted letter was emailed to all GCTF council members for their review and additional comments.
  - iii. Additional comments/suggestions made by GCTF council members for the letter:
    - Due to the pandemic and the loss of wages for many people, cancer treatment and continuing continuity and has been a challenge for many of our cancer



- Highly consider the impact that has made to our people, our cancer community (*F. Ouhadi*)
- Private Insurances does not cover the cost of Immunotherapy regiment as a treatment for cancer patient (*F. Ouhadi*)
- Most of the private insurance's companies in Guam do not cover transplants, especially with leukemia patients that require a bone marrow transplant (C. Felix)
- Opportunity to look at our pool of applicants and identify where the gaps are, and target those others as potential applicants to fill those gaps (*Y. Paulino*)
- Identify people or organizations that are able to apply to provide those services (Y. Paulino)
- b. Request a letter from the Non-Profit Organizations to provide GCTF an overview of how the funding has helped with their mission
  - Number on how many of their service community they were able to assist (K. Leon Guerrero)
  - Breakdown of what GCTF have provided ex: copayments, medication, travel, etc. (*C. Catro*)
  - July 15<sup>th</sup> is the deadline to submit letter to the legislature to request for additional funding
  - For old business letter "b" change request a letter to request information (*R. Leon Guerrero*)
- c. Revisit issue of Revised GCTF Rules & Regs 'comments' from public hearing
  - Need to address the concerns that were brought up about the revised rules and regulations (*R. Leon Guerrero*)
  - Consider the facts, arguments or written data or views that were stated at the public hearing (A. Camacho)
  - Before submitting the packet to the legislature (A. Camacho)
    - 1. minutes about the revised rules and regulations
    - 2. council must file with the speaker of the legislature (printed/ electronic PDF or proposed rules and a printed and identical PDF copy) which will consist of the following:
      - i. proposed rules
      - ii. notice of public hearing
      - iii. transcript of the public hearing
      - iv. minutes of the meeting of the council where the council considers the testimony presented in the public hearing
    - 3. packet must be approved by the UOG President and Legal Counsel
  - Comments were all discussed and attached the comments to the submission (K. Leon Guerrero)
  - Went through all the comments made by Senator Louise and other testimonies that were presented (C. Castro)
  - It would probably be faster just to go to that last meeting and look at the comments (K. Leon Guerrero)
  - View recordings and all meetings that happened after the March 25<sup>th</sup> meeting (Y. Paulino)

- Application Packet for FY 2022 proposed timeline
- a. Release FOA in early July
  - First week of July (R. Leon Guerrero)
- b. Informational webinar mid-July
  - To be determined (*R. Leon Guerrero*)
- c. Deadline for applicants to submit
  - August 31<sup>st</sup> (C. Castro and K. Leon Guerrero)
- d. Review of applications completed by
  - September 30<sup>th</sup> (*R. Leon Guerrero and K. Leon Guerrero*)
- e. Process in September/October so that applicants can start November 1st
  - Applications reviewed by early September (R. Leon Guerrero)
  - Council is required to follow the old rules and regulations until the new rules become effective (A. *Camacho*)
  - In the old rules and regulations, the University shall announce the availability of the awards in each fiscal year on or before April 1<sup>st</sup> (*R. Leon Guerrero*)
  - If this is still in line with the old rules and regulations, I'd like to move that we proceed (C. Castro)
  - Would like to make a motion to approve the process- 1<sup>st</sup> C. Castro, 2<sup>nd</sup> Ken Leon Guerrero, Motion Carried
- f. Funding for new awards will be November 01, 2021- September 30, 22 (C. Castro)
